Dear ITF Grand Masters and Masters,

I hope all of you are staying safe and secure.

1. The ITF HQ would like to inform you of the decisions of the ITF Executive Board which would be in force from 2022.

The NGBs/AGBs must register all the members to the ITF Database till the first half of 2022.

The ITF Certificate Application System through the ITF DB platform will be applied by the ITF HQ from the second half of 2022 as well.

The ITF members who fail to register to the ITF Database by the designated date are not entitled to get the benefits as the ITF member from 2022 such as the promotions or being disqualified from attending the ITF-endorsed events like the World/Continental Taekwon-Do Championships.

This failure in this ITF Database registration of the ITF Members is a full and exclusive responsibility of NGBs/AGBs.

For this purpose, you are strongly asked to contact Mr. Anton Archipov, the ITF Data Protection Officer, at his e-mail([a.archipov@taekwondo-itf.com](mailto:a.archipov@taekwondo-itf.com)) at your earliest convenient time.

2. All ITF Members are cordially required to pay 10 Euro for the Annual Membership Fee from 2022 to perform the normal activities throughout the whole year 2022 as ITF Members in good standing.

As for the NGBs/AGBs that completed the registration of their members with annual membership fee payment, the Annual Plaque Renewal Fees payable to the ITF HQ on every year's basis will be waived for those schools/clubs under the respective NGBs/AGBs from 2022.

Those who do not make the payment on time are to be excluded from the ITF activities like Promotion or be disqualified from attending the ITF-endorsed events, including but not limited to the World/Continental Championships.

The NGBs/AGBs should be responsible for collecting this Annual Membership Fee from every/each member under you and must send it to the ITF HQ together with submitting the List of the Members who paid the fees for their active memberships in the respective year.
